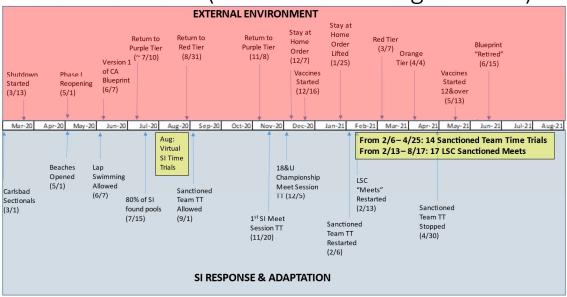

Challenges Facing LSC Across the Country

- Membership was down 15-25% last year
- LSC unable to give travel funds last year
- · LSC will not be able to give travel funds this year
- · No 12&under / unvaccinated swimmers allowed in any college pool (including junior colleges)
- Spectators aren't allowed given facility limitations and won't be through this season
- · Hurricane Ida has closed pools all over the East for multiple months
- Full COVID protocols are required by facilities because 12&unders are not vaccinated
- No / very limited access to pool as swim teams have lower priority than other groups
- Facility staffing shortages @ pools (specifically lifeguards) mean pools are closing at least owneed day per week limiting practice time
- LSC are losing money given facility restrictions when hosting meets which will limit what can be provided to teams / swimmers
- · Loss of officials to support swimmers / meets effectively

LSC Additional Support for Teams

- Early parts of COVID, ran Crisis Response and then Business Support Team to provide information and help with pool openings
- Provided assistanceand information to USA Swimming Grant program in Summer 2020
- Mental Health Education Opportunity for Coaches in September 2021
- Changed sanction and splash fee charges to help with teams running team time trials in a cost effective manner
- Ran LSC meets throughout 2021 so teams did not have risk of meets being cancelled due to COVID rules nor require parents to volunteer
- Did not charge official fines when teams were unable to provide sufficient officials for meets

Officiating, Admin, & Timing System Operator "Crew"

- Challenges Faced:
 - Updated timing system as COVID hit
 - Unused equipment always becomes problematic
 - Over 30 officials (over 25%) stopped officiating
 - Two timing system operators chose to take a break / leave
 - Constantly changing rules about what was allowed and how best to manage
 - Visits by police / facility officials at time trials and meets in Fall and Winter

- Accomplishments:
 - Successfully supported all the time trials and meets
 - Equipment has returned to being in great shape and highly reliable
 - Adapted procedures / coverage / minimum requirements / communication to manage conditions
 - New timing system operator being trained
 - 9 new officials are trained; 4 more completing their training so back up to almost 100 officials
 - Supported all the national meets held in California (US Open, TYR Cup, Olympic Trials, Sectionals, Futures, Summer Championship, and Senior Zones)

Other "Odds and Ends" for the Year

- Completed our first ever USA Swimming financial procedures review and passed
- Built out a google drive for LSC documents
- Have sufficient funds on hand to fully support our standard programs this year
 - Age Group Zones andAll Star Dual Meet,
 - Senior Travel
 - USA Swimming Collaboration and Educational Opportunities
 - Club and Athlete Support Programs
- Received logo redesign from USA Swimming for us to review / adapt

Reasons for the Difference (i.e., the Year ofCovid):

- LSC Board voted in May to not send a team to Age Group Zone meet in Dallas Texas (indoor pool) -- \$40,000
- All USA Swimming events / trainings / camps were virtual -- \$15,000
- Less meets / meets were run by the LSC to minimize risks -- \$10,000

2020 -2021 Financial Review

- Finance Committee Proposal:
 - Leave investment account "as is":

 - Cash to be used as needed to ensure budget balances this year Investment base is about 1 to 1.25 expected year expenses which is in line with the recommendation of having a full year of savings available
 - Surplus:
 - Set aside \$25,000 to support 2024 Olympic Trial participants (this is extraordinary expense every four years and ensures we have funds available)
 Do a one time "COVID" rebate to teams (~\$41,000)
 - - Rebate recognizes
- teams could not host meets
 teams had extremely limited ability to fundraise for 18 months
 Teams had a lot of extra costs given social distancing requirements / pool rental etc.

 Rebate Structure and Eligibility:
 Team must have been registered in SI for 2020 2021 year
 Team must be registered for 2021 2022 year in SI (NO LATER THAN 11/30/2021)
 Team swims year round in age group swimming (i.e., not a university affiliated or pro team)
 Rebate will be \$10 for each registered swimmer as of 8/31/2021 (end of 2021 swim year)
 Goal will be to pay repeate to cluss in December and recognize in 2020 2021 financials
 - Goal will be to pay rebate to clubs in December and recognize in 2020 -2021 financials
 As needed, move cash from investment account to balance year to 0.
