General Chair Report - Sally Taggart

Board Orientation Powerpoint has been updated. A General session was held for the new board on Sunday, December 12th.

Affiliation Agreement with USA Swimming has been signed. This will be in place with USA Swimming through December 31, 2023.

Brian Torio (NCA) has been confirmed at new Operational Risk Chair.

Via email vote with board, agreed to raise Sr. Classic facility rates by \$5 to ensure that revenue budget would be met given increased costs of hosting meet.

In person (!!) strategy session for SI was held on Monday, January 17th. A survey was sent out to head coaches, committee members and board for input. Twelve people (including 4 athletes) attended. We updated SI mission, vision, values, agreed focus areas for the next three years (Communication, DEI, and Swimmer Development / Retention), and discussed next steps with getting a logo which is in compliance with USA Swimming standards – pulled for information and request for help.

Request for help: 1 coach, 1 non-coach and 1 athlete to address each of the 3 areas (Communications, DEI & Retention) and report back at March meeting.

Request for help: At least 2 people to work with USAS Marketing Dept. in creating new logo – John McGlynn and Mary Redmond will head project.

Governance: recommendation on update for conflict of interest to update our policies and procedures has been made and is included in the powerpoint presentation for approval. Specific document is included as an attachment. The intent is to simplify process and align with USA Swimming. Pulled for discussion and vote

SI Board Members are required to sign Conflict of Interest Policy – M/S/APPROVED

Registered individuals 18/Over are not covered by USA Swimming Insurance if their APT has expired or they have not taken the course once they turn 18.

Requirements must be kept current at all times. There is no grace period; coach membership is not valid if any of the requirements lapse or expire. A coach does not have USA Swimming insurance coverage if his/her membership is not valid. To help coaches manage their membership requirements, the date that each requirement expires is printed on their USA Swimming coach membership card, as well as being available on the Deck Pass app and through the Club Portal. <u>Meet registration date change:</u> Clubs are <u>not</u> reviewing their athlete's registration before entering them in a meet. It is the host club's choice whether to accept athletes who are not registered by the meet date. There will not be refunds given to teams who enter swimmers who are not registered. Fees for meet entries are required to be mailed within 48 hours of submitting entries.

Beginning for the 2022 Meets, the meet entry date and registration date will now be the same. If the swimmer is not registered by the entry date they will not be allowed to participate in the meetthere will not be any exceptions as teams are responsible for making sure all their athletes are registered timely. The Club Portal is what teams can use to run a list of currently registered swimmers- this will also identify those athletes who need to complete their APT. Age Group Vice Chair - Sean Redmond

January 8-9, 2022, San Diego Swimming sent 43 swimmers as part of our first All-star team to Arizona for a dual meet. This was the first all-star team for two years, the last was also to Arizona in January 2020.

Although we did not fill the team to its max capacity; 9 swimmers per age group and gender; we still were competitive with Arizona. We did lose the meet 2,140.50 to 1,598.50. There were some great races and some of the age groups were very competitive.

I think that the swimmers and families did have a great time and there is talk about next year. In discussions with Arizona, we would like to have the meet in San Diego on the same weekend; the week before MLK weekend – program committee asked to incorporate into plans and confirm by May. . We discussed some minor changes in the format and will work on that shortly.

Due to some unfortunate circumstances, I was not able to rent a van; so, Mary drove her van and I drove my car. We had two coaches who opted to drive themselves in their own vehicles. We also had two coaches that had to back out at the last minute. Recommendation is pay \$100 to each coach that drove their own car to offset gas costs. John McGlynn was able to step in for one of the groups and I filled in for the other group. We also had

two of our SI officials go to the meet and worked as ST officials. We did offer to pay for their rooms for the one night. We are still waiting for AZ Swimming to post the results on SWIMS. They are for waiting for the meet referee and/or officials chair to approve them.

I did talk to the swimmers and parents and mentioned that there will be another opportunity for them to be part on an All-star team this summer. The Western Zone Age Group Championships August 3-6 at Elk Grove, CA (near Sacramento). I am planning to get some information out on the SI web site in the next 4-6 weeks with costs, time standards and location. As an LSC we are still looking at having the swimmers traveling with their families. General timeline for Age Group zone selection is as follows:

Mid February – information available on age group zones; start discussions with coaches about helping Early June – post application to website; have coaches selected July 19th – close applications for team July 24th – notify all applicatants

I. UVA Consultation:

Problems identified:

- Website:
 - O Header, labels, and content on DEI landing page are all over the place and do not communicate DEI messaging to people unless they know what they're looking for and exactly where it is.
 - O DEI changes are not highlighted: bylaws, policies, procedures (news updates essentially)
 - Comment section is disabled; no contact info listed visibly for members
 - "Equity" and "Equality" used interchangeably even though they mean completely different things
 - O DEI tab is hidden within Athletes tab
- Content
 - DEI resources are outdated
 - No photos whatsoever showcasing the diversity of the LSC
 - Mission Statement does not reflect a commitment to diversity
- Structure
 - o POC not very heavily represented in leadership positions

- O DEI language is not actively used in both content and website: DEI should be everywhere not just in a bubble
- Recruitment & Retention
- O Outreach program lacking in visibility and only encompasses one category of membership Combined gives impression that DEI is only done for compliance.

Recommendations

- Restructure the website to be more user friendly and easy to navigate to find DEI resources
- "Check the box" campaign and active display demographics of the organization
- Create & distribute graphics highlighting the Outreach program and its eligibility characteristics to help with enrollment

Winter CA/NV Sectionals was held at Golden West College 12/16 - 12/19. From what I gather, there were about 700 swimmers and the meet ran very well. As far as I know, no SI swimmers attended the meet. With the obvious interest (700 swimmers) the CA/NV has decided to continue to have two short course sectional meets (one in December and one in March) for the foreseeable future.

Spring CA/NV Sectionals is scheduled for March 3-6 at Alga Norte Pool – Hosted by North Coast. The meet format is available online. Entries are to be done through USA swimming's OME system. Apparently there is currently an issue with the OME, that should be resolved soon if not already.

Winter Nationals was held in Greensboro NC at the beginning of December. A few post grad SI registered swimmers were in attendance.

Winter Juniors was held in Austin at the University of Texas . 25 SI swimmers attended the meet. 21 for individual events and 4 relay only swimmers. Highest individual event finish: Kathryn Hazle (NCA) 4th in 400 IM and 200 Br. Highest relay finish: CSTE 2nd mens 200 medley relay Full results available on USA swimming website. Numerous SI individual and relay records were broken.
